Election of Executive Committee Member

Appointment of Voting Delegates

In accordance with the ECAHO Constitution each **Full Member Organisation** has the right to appoint two Voting Delegates for the AGM. Where there are two Full Member Organisations per country, each Full Member Organisation has the right to appoint one person.

Only Voting Delegates whose names have been brought forward by their Full Member Organisation will have the right to exercise a vote at the AGM.

Full Member Organisations are requested to return the attached form "Appointment of Voting Delegates" before 31st January 2010.

Unpaid Membership Dues

Member Organisations are reminded that in case they haven't paid their membership dues they will not have the right to exercise their vote; any member which did not pay his membership dues will be brought forward to the AGM.
